He served as chairman and CEO until taking Ascend public in 1994.

After Ascend’s initial public offering and over the next several years, its stock split four times, returning \$840 dollars for every initial \$1 invested. The company grew to 4500 employees with revenues in excess of \$2 billion. Mr. Ryan then founded Entrepreneur America along with his wife, Terry, after selling the company to Lucent for \$25 billion. Entrepreneur America is a mentoring organization that helps entrepreneurs reach multi-billion dollar valuations.

“After building Ascend and working with dozens of entrepreneurs, Comply365 is definitely a company to watch. It has the potential to be a billion dollar plus company in the next few years. I am excited to play a role in helping them achieve this goal,” said Ryan.

Rob has taught at Cornell University and has received the Cornell Entrepreneur of the Year Award in 2002. He is currently working with a select group of entrepreneurs.
